Important Instructions

Duly completed Application Form should be sent by Registered Post, Courier or by Hand to the **Secretary, Indian Association of Hill Farming (IAHF), Agronomy Section, ICAR Research Complex for NEH Region, Umiam-793103, Meghalaya**, so as to reach him not later than **10 November, 2015**.

- IAHF calls for Best Ph. D Thesis Award 2013 and 2014 (total 02 award)
- Only one award will be given every year across the discipline
- Award carries a certificate and a memento.
- Degree awarded (date of viva-voce) on or before 31 Dec of previous year is eligible for next year. For example degree awarded on or before Dec 31, 2012 is eligible to apply for the award for 2013 and son on.
- **The work should have been done in a hilly station (Himalayan States/North East/Andaman etc) in India.**
- Provide soft copy of application along with evidences for publication/other claims in the CD with appropriate headings for easy reference.
- Claims without evidence (soft copy) will not be considered for scoring.
- Kindly provide self scores for each s. no of application with adequate breakup. The same will be cross verified by the screening committee/evaluation committee. Please use a separate sheet for self scoring and enclose after abstract of application page.
- Submit **one copy of thesis**. The award winning thesis will be retained by the society.
- Submit **TWO COPIES** of Application through the Major Guide/Head of the Division.
- Application not received within closing dates will not be considered.
- Society may give sleeper class train fair only to receive the award by shortest possible route (all other costs to be borne by the awardee)
- The Society may ask the award winner to give a **presentation of 10 minute** (not more than 15 slides) during its Seminars/Award ceremony.
- No award will be given if suitable entries are not received
