**TERMS & CONDITIONS FOR RATE CONTRACT OF SERVICES FOR THE YEAR 2014 – 2015**

1. Prices: In Indian Rupees only.
2. ST/Packing/Forwarding: The Institute is entitled to concession on Sale Tax applicable to Educational/Research Institute/Lab. Sales Tax may be charged accordingly. Packing/ Forwarding charges for pickup and delivery will be borne by the Party.
3. Excise duty: Exemption certificate will be issued, if required.
4. Order for: Materials for service should be picked up and delivered back accordingly as per the specifications mentioned in the work order.
5. Delivery: FOR ICAR Research Complex for NEH Region, Umroi Road, Umiam – 793103. (Meghalaya) or its Regional Centres or as specified in the work order.
6. Service Delivery Period: 15 days or as per the time mutually agreed depending on work.
7. Payment: On the receipt on bill basis.
8. Defective Services: Services if found defective at any time, the same must be rectified immediately and any loss occurred to our Institute due to the use of your faulty material/ services all damages/loss shall be borne by you and payment of bill, if already made shall be refunded/will be deducted from any of your pending bills. The Rate Contract is also liable to be cancelled in case of such eventually. If material for service is lost in transit, or in processing, all sample preparation cost and other related losses would be borne by the party.

9. Part services: Part services shall not be accepted until and unless it is supported by convincing reasons and approved by the Competent Authority.
10. Late services: A penalty of 0.5% per week or part thereof will be deducted in respect of delayed services calculated on the order value of items delayed limited to 10% of value.
11. Fluctuation in quoted Prices: The quoted price of the articles shall remain stable throughout the contract period. Any additional levy of Taxes by the Government in the course of contract would be payable & also the reduction of quoted price (s) on account of lower levy etc. of any of the articles shall have to be passed on to ICAR Research Complex for NEH Region, Umroi Road, Umiam – 793103. (Meghalaya).
12. Charging Higher quoted Rate(s): The firm shall not charge from ICAR Research Complex for NEH Region, Umiam/Centres higher quoted rate (s) than for the same items to any other organization. A certificate from the party in this regard should be enclosed. If, at any stage it is found, the difference of amount shall have to be refunded to ICAR Research Complex for NEH Region, Umiam. The rate(s) is liable to be cancelled and steps will be initiated for blacklisting of the firm.
