## **OPEN TENDER**

**Sealed bids** are re-invited from the reputed registered firms/ manufacturers/ authorized dealers for supply of **branded Toners/Cartridges/Ink cartridges** etc. of different specifications for Printers & Fax Machines etc. as listed out in the Tender Document to ICAR Research Complex for N.E.H. Region, Umroi Road, Umiam, Meghalaya. The detailed specifications of the items, terms & conditions, etc are given below:-

- 1. Cost of Tender paper **Rs.500.00** (Rupees five hundred only, **(Non- refundable)** to be deposited in the favour of the Director, ICAR Research Complex for NEH Region, Umiam, by means of Demand Draft payable at SBI ICAR Complex Branch, Umiam, Non submission of the cost of the Tender paper shall lead to non consideration of the Tender.
- 2. The tenderers shall have to mandatory deposit consolidated EMD of Rs.1000/- (Rupees one thousand) only in the form of Demand Draft valid for 6 (Six) months, drawn in favour of the Director, ICAR Research Complex for NEH Region, Umiam, Meghalaya, payable at SBI ICAR Complex Branch, Umiam, along with the quotation. Non compliance to this shall lead to non consideration of the bid.
- 3. The Tender should consist of two Bids- The techno-commercial bid/Technical bid (Bid 'I') and the Financial bid (Bid 'II'). Both must be submitted in two separate envelopes to be sealed and put in a single main cover. The outer main cover should be super scribed "TENDER No.RC(S)24/2016 dtd.15/06/2016 for supply of branded Toners/Cartridges/Ink cartridges and addressed to "THE DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION UMIAM, MEGHALAYA-793103". You should give the complete address on the bottom left corner of the Main Cover. Tenders may be sent by Registered Post or may be hand delivered in the Tender box, kept in the Office Chamber of the CAO's/AAO(S) ICAR Research Complex for NEH Region, Umiam, Meghalaya-793103 not later than 12:30 P.M. on the 15th July, 2016. Tenders received after the due date and time shall not be considered under any circumstances.
- 4. Furnishing of related documents like detailed specifications, technical literature, brand name, model and make, catalogue, authorization letter, Dealership Certificate, company registration certificate, product certification, price list (if any) etc. is mandatory, Dealership certificate/Agency Certificate for the manufacturer/manufacturing firm should be enclosed if the rates are quoted by the Dealers/Agents. Sales tax certificate, tax clearance (up to date), valid CST/VAT registration certificate, last 3-5 years financial standing etc. along with all the commercial terms and conditions. Failing which the quotation shall not be considered.
- 5. **The supply is effected at DGS&D rate contract, wherever is applicable**. The rate should be quoted for list of items as per the tender document.
- 6. Eligibility of the bidders-Bidders should
  - I. Should be either original manufacturer of the item covered under this tender or Authorized distributor/Supplier/dealer of such items. A duly attested copy of such authorization has to be compulsorily attached with the technical bid, failing which the bidder will stand disqualified. The authorization letter/Certificate from original manufacturer should be valid for the entire period of one year contract.
  - II. Have minimum **1 year** of experience of supplying various branded Toner Cartridges/Ink cartridges in bulk to the Departments/Ministries/organization of the Government of India/State Govt. (Valid proof has to be attached).
  - III. Not have been blacklisted by any of the Depts/Ministries of the Govt. of India.
- 7. **The financial bid should consist of the rates only**. Price quoted for each particular item should be enclosed separately and must be given per unit/nos. and must be all inclusive, including packing, forwarding, loading, unloading, delivery, taxes, VAT etc., as may be applicable. The amount of discount, etc. offered by the bidder should be specifically shown as admissible. **The rates quoted should be upto ICAR Research Complex for NEH Region. Umiam (Divisions, Sections, Stores)**, for the mentioned items. The rates must be valid for at least for 01 (one) year from the date of quotation.
- 8. The Buyer shall not be responsible for payment of transit insurance charges.
- 9. Payment shall be made only on actual delivery in good condition and successful installation and demonstration (which should be free of cost and must be completed before payment).

- 10. ICAR Research Complex for NEH Region, Umiam, Meghalaya, being a Scientific and Research Organization, is exempted from payment of Excise Duty (Certificate to this effect will be provided).
- 11. The Firm/ Agency run by the Non-Tribal should produce Trading License issued by the KHADC & also produce Municipal Trade License as applicable state to state & Tribals should provide Schedule Tribe Certificate, failing which the tender are liable to be rejected. Non submission of Trading License, tender rates shall be rejected / not to be considered. The participating the tender from State other than Meghalaya have to obtain KHADC before actual supplying of the materials.
- **12.** The successful Bidder, upon receipt of the Award for supply, shall have to enter into an Agreement with the Institute, He shall also have to deposit a sum of **Rs.10,000/-** (Rupees ten thousand) only in the form of Demand Draft/Bank guarantee, valid for atleast 1 (one) year, drawn in favour of the Director, ICAR Research Complex for NEH. Region, Umiam, Meghalaya payable at SBI, ICAR Complex Branch, Umiam as a Performance Guarantee.
- 13. Performance Bank Guarantee is required for all indigenous items also. For items less than Rs.50,000/- the amount should be 5% of the actual cost of the item and for items more than 50,000.00 the amount should be 10% of the actual cost of the item. The bank guarantee should cover the entire guarantee/ warranty period which should be of at least one year duration.
- 14. The selected bidders must complete the supply/ repairing/installation/ demonstration within the stipulated time limit mentioned in the supply order. In case of delay in supply, penalty will be imposed @2% per week, subject to a maximum of 10% of the FOB value.
- 15. The guarantee/ warrantee should be from the date of installation. All guarantee/ warranty services should be attended within a maximum limit of 15 days, failing which, proportionate deductions from the security deposit may be made at the discretion of the Institute.
- 16. The Director, ICAR Research Complex reserves the right to reject any tender in part or full, without assigning any reason thereof.
- 17. Legal jurisdiction for all disputes shall be within the purview of the Shillong Court.
- 18. You should mandatory sign on every page of the Tender Document, which would show their unconditional acceptance of all the terms and conditions of the Tender Document. You shall give an undertaking that they fully and unconditionally agree to abide by all the terms and conditions which, if needed, may be modified at the discretion of the Competent Authority, in supply order, for which confirmation from the supplier shall be taken.
- 19. You should mandatory give your CLJrrent, PAN Card No., TDS& other Bank A/C details to enable the office for releasing the dues via e- payment basis.
- 20. The Techno-Commercial Bids/Technical Bid (**Bid I**) shall be opened on <u>15<sup>th</sup> July, 2016 at 02:30p.m</u>. in the Committee Room, Administrative Block, ICAR Research Complex for NEH Region, Umiam, Meghalaya. Interested bidders may attend the opening.
- 21. If the above mentioned closing /opening day of the tender happened to be non working date due to Bandh/Strike as any other reasons, the tender will be received & opened on the following working day at the same time except on the 2<sup>nd</sup> (second) Saturday.
- 22. Other terms & conditions, as may be decided by the Competent Authority from time to time, depending upon the condition & requirement of the supply. The intimation in this regard, shall be provided well in advance & the bidder/ supplier shall be bound by the said terms & conditions.
