TERMS & CONDITIONS OF THE TENDER

1. **Cost of Tender paper of Rs.1000/-(Rupees One thousand)only** (Non- refundable) to be deposited in the favour of the Joint Director, ICAR Research Complex for NEH Region, A.P Center, Basar-791101 by means of Demand Draft payable at SBI, ICAR Complex , Basar. Non submission of the cost of Tender paper (consolidated) shall lead to non- consideration of the Tender.
2. The Bidders should submit the proposals in two parts:
 - a. Technical Bid (Bid-I)
 - b. Financial Bid (Bid-II)
3. Technical part should contain all such details as mentioned in the Bid Documents.
4. Financial part (BID-II) should contain the financial bid inclusive of all admissible taxes, duties and levies, freight charges, packing, forwarding, Delivery charges, Taxes, VAT, GST etc., as may be applicable etc.
5. **The rates quoted should be FOR up to destination as mentioned in Appendix-I under ICAR Research complex for NEH Region, A.P center, Basar-791101 for the mentioned items.**
6. The financial Bid should consist of the Rates, their detailed break- ups, etc. Non- compliance of this shall lead to non- consideration of the Bid. The rates must be valid for at least for 1(one) year from the date of quotation.
7. These two parts (BID-I & BID- II) should be submitted in separate sealed envelopes. Both envelop should then be sealed in a third envelop super scribed as **“TENDER NO. AR/STORE/NEC/44/2017/ dated.23/08/18 DUE ON 12/09/18 FOR PROCUREMENT OF PLANTING MATERIALS OF PINEAPPLE (Suckers/ Slips) UNDER NEC FUNDED PROJECT”** and addressed to **“The JOINT DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION BASAR, ARUNACHAL PARDESH-791101”**.
8. **The cost of the Tender (consolidated) as well as the Earnest Money (consolidated) in the form of Bank Draft (Only SBI) along with all other Technical Details should be mandatory kept in the Technical Bid only. Cheque/Bank Guarantee/ fixed deposit receipt/ money orders/Cash etc. are not acceptable towards deposit of earnest money.**



10. **Details of Earnest Money i.e. draft number and date should be indicated on the cover of the big envelope** otherwise the tender may not be received or opened and returned to the party. All Tender should be sent by Registered Post. Tender to be hand delivered should be put in the Tender Box, kept in the office chamber of Administrative Building, ICAR Research Complex for NEH Region, A.P Centre, Basar, Arunachal Pradesh-791107 not later than **02:30 P.M. on 12/09/18** Tender received after the due date and time shall not be considered under any circumstances.
11. On the date of opening, only Part-I (Technical Bid) will be opened. Part-II (Financial Bid) shall be opened subsequently only of those tender, whose **Technical Bid qualifies as per the laid norms of this tender.**
12. Composition of Technical Bid-
- Profile & Track Record of the company/firm.
 - Document in support of past experience in supply of Pineapple (*Suckers/ Slips*).
 - The Pineapple (*Suckers/ Slips*) should be from Arunachal Pradesh and other North Eastern States of India.
 - Photo copy of PAN No. issued by Income –Tax Department. Photo copy of Service Tax/sale tax/ VAT Registration etc. (if not applicable submit the relevant document).
 - License for supply of Pineapple (*Suckers/ Slips*) from Government of India.**
 - Non refundable tender Document Fee of Rs.1000/-(Rupees One thousand) only in the form of Demand Draft from any SBI Bank drawn in favour of the Joint Director, ICAR Research Complex for NEH Region, Basar Arunachal Pradesh payable at State Bank of India Basar Branch (if exempted/ relaxed submit the relevant document in support of claim). Refundable Earnest Money Deposit (EMD) of Rs. 20,000/-(Rupees Twenty thousand) only in the form of Demand Draft from SBI Bank, drawn in favour of the Joint Director, ICAR Research Complex for NEH Region, Basar Arunachal Pradesh. (if exempted/ relaxed submit the relevant document in support of claim). The cost of the tender paper as well as the Earnest Money along with all other Technical Details should be mandatory kept in the Technical Bid only. Non submission of the Bid Security with quotation shall make the quotation/ bid liable to be rejected.**
 - Furnishing of related documents like detailed quality of the materials etc.
 - The planting materials should be diseases free.
 - Details of stocks available of the said Pineapple (*Suckers/ Slips*).
 - No objection certificate for supply of Pineapple (*Suckers/ Slips*) from Government of India
 - The bidders should mandatory sign on every page of the Tender Document, which would show their unconditional acceptance of all the terms and conditions of the Tender Document and submit along with the technical bid.
13. Payment shall be made on actual delivery in good condition.
