Sealed quotations are hereby invited for the Audience of the vehicles on or before **20<sup>th</sup> December, 2018 up to 02.00 PM** as per terms & conditions mentioned below:-

**TERMS & CONDITIONS**

1. Tender shall be accompanied with a refundable deposit of **Rs. 10,000.00** (Rupees ten thousand) only as a Security Money in the form of **B/D** drawn in favour of the Director, ICAR Research Complex for NEH Region, Umiam-793103, Meghalaya payable at SBI, ICAR Research Complex for NEH Region, Umiam-793103.
2. The Security money will be refunded to the unsuccessful bidders after the Auction is over. The auctionable vehicles may be inspected by the interested parties on any working day between **10:00 AM to 03.00 PM**. The details of the auctionable vehicles are as per **Appendix-1**.
3. The auctionable vehicles will be auctioned subject to explore the auction value not less than the offset value fixed by the Committee in due course.
4. **The Director reserve full right to accept or reject any or all quotations without assigning any reason thereof.**
5. The highest Bidder will be offered and will have to deposit the sale proceed in full in the form of Bank Draft addressed to the Director of the Institute and handed over to the undersigned for issuing necessary order for lifting of the unserviceable items.
6. The tender will be opened on **20<sup>th</sup> December, 2018 at 02.30 pm**.
7. The security money as deposited will be forfeited if the said vehicles are not lifted within the specific time. The Institute will not be responsible for any loss or damage items if not lifted immediately after finalization of the bid as it where is basis.
8. For the auction of the vehicles shall have to be lifted/removed within **5 (five)** working days otherwise penalty of **Rs. 500/- per day** shall be charged.
9. The tender/bidder is requested to physically inspect all the auctionable vehicles and quote their rates accordingly. In case of any shortfall of the items in the time of lifting. An amount shall not be re-funded back under any circumstances.
10. Tenderer is/are requested to physically re-verify once again the auctionable Vehicles and quote their rates accordingly.
11. **KHADC license.**
  - a. The Firm/Agency run by the Non-tribal contractor's /firms/companies/ suppliers/ stockiest/ banded warehouse/Private carriage contractors/Co-operative Societies etc. should produce Trading License issued by the KHADC (Govt. of Meghalaya) and may be kept in the Technical Bid (Bid - I).
  - b. Submission of tender paper does not fall under trade as per the above said act. However, if a Non-tribal becomes a successful bidder he has to furnish License issued by the KHADC (Govt. of Meghalaya) before any work involving trade is issued to him.

All bidders shall give an undertaking that they fully and unconditionally agree to abide by all the terms and conditions which, if needed, may be modified at the discretion of the Competent Authority, in supply order, for which confirmation from the supplier shall be taken. Non submission of the undertaking may lead to rejection/ non-consideration of the tender/or outright rejected by the office.
13. If the above mentioned closing/opening day of the tender happened to be non-working date due to Bandh/Strike as any other reasons the tender will be received & opened on the following working day at the same time except on the 2<sup>nd</sup> Saturday.
