
TERMS AND CONDITIONS

1. The quotation/tender should consist of two bids-The Techno commercial bid(bid-1) and The Financial Bid(bid-2) both must be submitted in two separate enveloped to be sealed and put in a single main cover. The outer main envelope should be superscribe as SHORT TENDER No. RC(MZ) TSP/2011/VOI. V/1667 dt 18.3.16 for supply of Arecanut leaf maker (2 nos.) at ICAR Mizoram Centre, Kolasib addressed to The Joint Director, ICAR Mizoram Centre, Kolasib-796081. The contractor should give their complete address on the bottom leaf corner of the main cover. All sorts of paper /documents like supplier registration certificate, GST, PAN card, tax clearance certificate etc..should be mandatory kept in the technical bid only. The financial bid should consist of the rate, their detailed break up etc. All tenders should be sent by registered post/hand delivered and should reached the office on or before dt.25/3/19 upto 1:00 pm. Tender received after the due date shall not be considered under any circumstances.
2. The tender papers may be obtained by payment of Rs 500/- (Rupees Five Hundred) only by a/c payee, demand draft/ bankers cheque drawn in favour of the Joint Director, ICAR Mizoram Centre, Kolasib being the cost of tender papers payable at SBI, Kolasib.

7. The Joint director, ICAR Mizoram Centre, Kolasib reserves the right to reject any tender in part or full without assigning any reason thereof.
8. Payment of supplier bill will be made by A/C payee/DD/Cheque from ICAR Mizoram Centre, Kolasib. It is mandatory to submit GST/ Tax clearance certificate at the time of payment of bill.
9. In case of any dispute The Joint director, ICAR Mizoram Centre, Kolasib shall be the sole arbitrator and his/her decision will be final and binding on the supplier.
