Important Instructions

Duly completed Application Form should be sent by Registered Post, Courier or by Hand to Pankaj Baiswar (Plant Pathology), Secretary, Indian Association of Hill Farming (IAHF), & Senior Scientist, Division of Crop Science, ICAR Research Complex for NEH Region, Umiam-793103, Meghalaya, so as to reach not later than 20th November, 2021

- IAHF calls for Best M.Sc. Thesis Award 2019 and 2020 (Total 02 awards)
- Only one award will be given every year across the discipline
- Award carries a certificate and a memento.
- Degree awarded (PDC/ Certificates) on or before 31 Dec. of previous year is eligible for next year. For example degree awarded on or before Dec 31, 2018 is eligible to apply for the award for 2019 and so on.
- The work should have been done in any hill stations in India.
- Provide soft copy of application along with evidences for publication/other claims in the CD with appropriate headings for easy reference.
- Claims without evidence (soft copy) will not be considered for scoring.
- Submit **one copy of thesis**. The award winning thesis will be retained by the society.
- Submit **TWO COPIES** of Application through the Major Guide/Head of the Division.
- Application not received within closing dates will not be considered.
- Society will give sleeper class train fare only to receive the award by shortest possible route (all other costs to be borne by the awardee)
- The Society may ask the award winner to give a presentation of 10 minute during its Seminars/Award ceremony.
- Final decision of Society President will be binding in all cases.
- Achievements/ Publication etc. up to the closing date will be considered for IAHF Award irrespective of year of Award.
