Terms & Conditions:

1. The appointment is purely temporary, time bound, contractual and co-terminus in nature for specified duration not exceeding the duration of the project. As the project is sponsored by India Meteorological Department, candidate will have no right to claim for regularization of service & in no way he/she shall be treated as an employee of ICAR.
2. The nature of duty apart from that written above includes field data collection from different location of the state, dissemination of bulletin and any duty assigned by the Nodal Officer of the project.
3. Depending on the number of the candidates for "Walk-in-interview", written test may be conducted covering class -XII level knowledge and those who secure more than the cut off mark decided by the institute shall be interviewed.
4. The place of posting will be at Umiam and the candidate must have to stay within the place of posting for timely recording of the weather data.
5. Emolument payable is consolidated (Rs. 15,000/- plus HRA) as per the norms fixed by IMD.
6. Age should be between 18-30 years as on publication of advertisement, with relaxation by 5 years for SC/ST and 3 years for OBC candidates.
7. No TA/ DA/ Fare and official accommodation will be provided for attending the Interview.
8. The institute reserves the right to cancel/postpone the interview without assigning any reason thereof. The institute also reserves the right to terminate the contract, even before completion of the project for which no appeal thereof can be made.
