NOTIFICATION FOR EMPANELMENT OF CONTRACTORS/FIRMS

Application for Empanelment is invited from the reputed and bonafide Contractors/Firms for the minor repair, renovation, petty construction works etc. in ICAR Research Complex for NEH Region, Umiam. As per the terms and conditions, the applications to be submitted to the office of the Estate Officer, ICAR Research Complex for NEH Region, Umiam on or before IC+6 December, 2013 upto 1.00 PM. The applications with all other relevant documents required to submit in a sealed cover/envelope with clear mention of the senders name with full address in left corner and must be superscripted as "Application of Empanelment of reputed and bonafide contractor in ICAR". The applications received after due date and time shall not be entertained under any circumstances.

- The application forms can be obtained from Estate Cell against a non-refundable fee of Rs. 1,000/- (Rupees one thousand) only in the form of Demand Draft (DD)/Banker's cheque (BC) in favour of "Director, ICAR Research Complex for NEH Region, Umiam" or may be downloaded from website (www.icarneh.ernet.in / www.kiran.nic.in). This DD/BC for the fee is to be submitted along with application form to the designated authority.

 NB: For each categories & class, separate application required to be submitted alongwith fee.
- The registration fee for the empanelment is Rs. 10,000/- (Rupees ten thousand) only for each arena of works/expertise (viz. Road/ Building/PHE/Electrical) in the form of Demand Draft (DD)/Bankers Cheque (BC) payable in favour of "Director, ICAR Research Complex for NEH Region, Umiam" have to submit alongwith the application form. The registration fee will be refunded to unsuccessful Contractors/Firms/Developers failing to complete / fulfillment for empanelment.

The applications without the above mentioned fees shall be liable for outright rejection. The TOC shall be carefully studied by the concerned for proper submission.

Terms of Conditions (TOC)

1.0 GENERAL:

- **1.1.** Empanelment of the reputed contractors/firms in ICAR Research Complex For NEH Region, Umiam, Meghalaya 793103 will be carried out for various Works category in various classes as per details given in Table-I.
- **1.2.** Contractor means —An Individual/Sole proprietorship/Partnership firm/Private Ltd Company/Public Ltd Company.

2.0 APPLICABILITY:

- **2.1** It is to be done to have a ready list of suitable and competent contractors form ICAR works so as to minimize requirement of verification of credentials of Contractors at the time of individual tenders. At the same time, only those contractors are allowed to continue in the list that remain active in ICAR and perform well. Empanelment does not necessarily for the schedule period, it may have to lease at any point of time at the discretion of the ICAR authority without serving notice thereby.
- **2.2.** Any Contractor is entitled to get Empanelment in ICAR under these rules provided the eligibility criteria and other conditions are satisfied. The enlisted contractors have to abide by all the rules made herein and as amended from time to time during the currency of their Empanelment.
- **2.3** Any Contractor having such individual as one of the partners/Director(s), who is dismissed as Government servant; or whose Empanelment have been cancelled, demoted to lower class, or having business banned/suspended by any Government Department in the past or convicted by a court of law shall not be entitled for Empanelment.
- **2.4** Any Engineer or other official employed in Engineering or Administrative duties in the Engineering Department of the Government of India/State Government or central/State PSUs is not allowed to work in ICAR either as a contractor or as employee of a contractor for a period of one year after his retirement from the service unless he has obtained prior permission of government of India/State Government or concerned PSU to do so. Even after Empanelment, if either the contractor or any of his employees is found to be a person who had not obtained the prior permission as aforesaid, the name of the contractor shall be removed from the list of enlisted contractors.
- 2.5 A Contractor is not permitted to have Empanelment in more than one name.
- **2.6**. A partner of a firm or a Director of a company enlisted as a contractor cannot be a partner / director/employee/GPA holder in any other enlisted firm / company in ICAR.

3.0 TERRITORIAL JURISDICTION:

3.1 The jurisdiction in which contractors enlisted in various classes shall be permitted to participate in the tender process is as given in Table-I.

4.0 SCOPE OF EMPANELMENT

4.1 The Contractors enlisted with ICAR shall only entitle him for being considered for issue of tender documents subject to the terms & conditions of individual Notice Inviting Tender for each specific work. It shall not confer any right on the contractor either to be necessarily issued tenders or award of work.

5.0 TENDERING LIMIT:

5.1 Tendering limit for different classes as per ICAR Empanelment Rules shall be as per details given in Table-I and will be applicable to all contractors whether enlisted after or prior to enforcement of these rules.

6.0 APPLICATION FORMS:

6.1 The application forms for Empanelment shall be downloaded from ICAR (www.icarneh.ernet.in) / Kiran website or may be obtained from the Estate Cell of the ICAR Research Complex for NEH Region, Umiam during the office hours in all working days.

7. 0 QUALIFICATION FOR EMPANELMENT:

- **7.1** Contractors are expected to keep abreast with Empanelment Rules as modified from time to time. The contractors desiring Empanelment shall have to satisfy the minimum qualifying criteria as specified in Table-I, before they can be considered for Empanelment.
- **7.2** The criterion for work experience, in case of Empanelment, shall be the satisfactory completion of requisite number of works, as the case may be, of prescribed nature and magnitude executed on independent contract basis during the last three years w.e.f. the date of receipt of application for Empanelment by appropriate authority (refer Table-I). The works should have been executed in the same name and style in which the Empanelment is sought.
- **7.3** Experience of contractors shall be reckoned upto the date of receipt of the application in the designated office. For works done, original or attested copies of certificates from the officers, not below the rank of Executive Engineer or equivalent, under whom works were carried out should be enclosed in prescribed Performa. In case of photo copy, the same shall be attested (in original) by contractor.
- **7.4** The financial soundness shall be judged on the basis of the Banker's Certificate (solvency) as the case may be, issued by the Bankers of the contractors on the format prescribed in *Annexure-V*. Such certificate shall be issued by a scheduled bank and shall be submitted, in original in a sealed cover to put inside the cover of the application.
- **7.5** The technical staff with suitable complementary staff required to be employed by various classes of contractors shall be as per Table -I.

8.0 EMPANELMENT PROCEDURE:

- **8.1** The contractor shall have to submit the application in a prescribed format (Annexure-I) complete with all documents as listed all other as per TOC in the Estate Cell, ICAR Research Complex For NEH Region, Umiam, Meghalaya 793103
- **8.2** The name(s), address(es) of the applicant(s), telephone numbers, & email-ids shall be mandatory and their appearing in various documents should be consistent.
- **8.3** In case of incomplete applications or if the applications are not accompanied with necessary documents the same are liable to be net rightly rejected.
- **8.4** If the Empanelment authority finds the contractor suitable for Empanelment, it shall issue the Empanelment order and otherwise, send a letter of rejection of the application to the contractor. The decision of the Empanelment authority shall be final and binding on the contractor.

- **8.5** The Empanelment authority reserves the right to limit number of contractors to be enlisted in any class or category or any other manner decided by the department.
- **8.6** Empanelment of contractors in ICAR may be closed at any point of time. No fresh application shall be received by any authority after issue of orders for closing the Empanelment process. However, all pending cases before the issue of orders shall be decided on merits.

9.0 EMPANELMENT FEE:

9.1. The application forms can be obtained from Estate Cell against a *non-refundable* fee Rs. 1,000/- (Rupees one thousand) only in the form of Demand Draft (DD)/ Bankers cheque (BC) in favour of "Director, ICAR Research Complex for NEH Region, Umiam" or may be downloaded from website. This fee is to be submitted along with application form to the designated authority.

The registration fee for the empanelment Rs. 10,000/- (Rupees ten thousand) only for each arena of works/expertise (viz. Road/ Building/PHE/Electrical) in the form of Demand Draft (DD) payable in favour of "Director, ICAR Research Complex for NEH Region, Umiam" have to submit alongwith the application form. The registration fee will be refunded to unsuccessful Contractors/Firms/Developers failing to complete / fulfillment for empanelment.

10.0 ELECTRICAL & CIVIL WORK LICENSE:

10.1 The contractors of Electrical as well as the Civil (Building/roads/PHE) Category shall have to produce valid license from the competent authority in the name of contractor. They shall keep valid license throughout the period of Empanelment by getting it renewed at suitable intervals and submit an attested copy of the same to the Empanelment authority after each renewal. In event of any discontinuity in validity of license, the Empanelment and authority to work in ICAR will also ceased to be valid. For applying tenders for a work they shall have to possess valid license of appropriate issued by Central /any State Govt from time to time.

11.0 PERIOD OF VALIDITY OF EMPANELMENT:

11.1 The Empanelment shall be valid for a period of three years. The Empanelment shall be open to review by the Empanelment authority and liable for termination, suspension or any other such actions at any time, if considered necessary, by the competent authority, after issue of show cause notice.

12.0 PERFORMANCE REPORT:

- **12.1** The contractor should fill up the details of works of appropriate magnitude, completed during last five years, in the Performa as given in —*Annexure III*".
- **12.2** The performance report in respect of the completed works shall be submitted in the Performa as given in *Annexure-IV*.

13.0 CHANGES IN STATUS OF FIRM WITHOUT PRIOR APPROVAL

13.1 Enlisted contractors shall not enter into any fresh partnership or change their constitution without the prior approval of the Empanelment authority. In case they wish to enter into any fresh partnership or change their constitution, they must intimate in advance full details of the intending partnership along with the draft partnership deed and other documents as per details given in *Annexure-II*. Any change in status of the Contractor as an individual or in the

constitution of firm, will be liable to be removed from the approved list of contractors of ICAR. This will also be applicable to the contractors enlisted as a Private/Public Company.

13.2 If a firm is converted into two or more firms by way of dissolution by partner, the new firm shall have to apply for Empanelment afresh on the basis of work experience gained as a separate entity. However, the proportionate value of the work experience, gained in the dissolved firm, may be attributable to various partners of the firm, while considering their application for fresh Empanelment.

13.3 If the number of original partners of a firm reduces less than half, due to any reason including death of the any partner(s), the Empanelment of the firm shall be withdrawn. (Original partner means constituent at the time of Empanelment and those who have remained as constituent for more than 5 (five) years.)

14.0 INTIMATION REGARDING CHANGE OF PERMANENT ADDRESS

14.1 While applying for Empanelment, the contractor should mention address of his registered office as well as Head Office, if different. All documents i.e. Banker's Certificate, experience certificate etc. should bear one of the above addresses, otherwise the same shall not be accepted.

14.2 The contractor shall intimate the change, if any, in any of the above addresses, in advance or maximum within one month of such change along with acknowledgement of noting down of such change in address from the Bank, Income Tax, Sales Tax authorities etc. Failure to do so may result in removal of his name from the approved list of contractors.

15.0 DISCIPLINARY ACTION / DISQUALIFICATION:

15.1 The Contractor shall abide by the Rules of Empanelment, and, by the terms & conditions of the Contract including Notice Inviting Tenders etc. The contractor shall timely and satisfactorily execute the works.

15.2 The Empanelment Authority under his/her discretion may appoint the committee to inspect the list of works submitted alongwith the application with regard to quality, timely and satisfactorily completion etc. and shall have right to take action against the Contractor, after the issue of Show Cause Notice. The decision of the committee shall be final and binding on the Contractor. The following disciplinary actions shall be taken against the Contractor:

15.2.1 REMOVAL FROM APPROVED LIST:

The name of contractor may be removed from the approved list of contractors, if the contractor has:-

- A. on more than one occasion, failed to execute a contract, or executes it unsatisfactorily, or,
- B. proved to be responsible for technical defects, on more than two works, or,
- C. failed to abide by the conditions of Empanelment, or,
- D. found to be given false particulars at the time of Empanelment/tender submission, or
- E. changed constitution of the firm without approval of the Empanelment Authority, or,
- F. changed permanent / business address of the firm without intimation to the Empanelment Authority, or,
- G. declared or is in the process of being declared bankrupt/insolvent, winding up, dissolved or partitioned, or,
- H. persistently violated the labor regulations and rules, or,

- I. persistently defaulted in settlement of Statutory Taxes such as Income Tax, Work Contract Tax, Sales Tax, Octroi duties, Service Tax, EPF etc. or
 - J. indulged in any type of forgery or falsification of records, or,
 - K. quoted for a tender under two or more firms where he is a Partner/Director/Owner/GPA holder.

15.2.2 DEMOTION TO A LOWER CLASS:

The name of contractor may be demoted to a lower class, if the contractor:

- A. fails to execute a contract, or executes it unsatisfactorily, or
- B. is proved to be responsible for technical defects, or
- C. is no longer in possession of adequate tools /instruments, technical personnel or financial resources or,
- D. is litigious by nature, or,
- E. violates any important conditions of contract, or,
- F. has adverse Performance Report, or,
- G. is responsible for a conduct, which may justify his demotion to a lower class.

15.2.3 SUSPENSION OF EMPANELMENT:

In case, there are allegations against a Contractor of a nature such that the Empanelment Authority is of the view that the Contractor may be guilty of an offence, which when established would result in his removal / banning business, the Empanelment Authority, pending full enquiry, may debar a Contractor for a specified period. In case the Empanelment Authority is of the view that the Contractor is guilty of an offence, which when established would result in his removal/banning business and it is not considered desirable to entrust new works or continue business with him, the Empanelment authority, pending full enquiry, may debar a Contractor for an indefinite period.

16.0 REVISION OF RULES:

16.1 The authority reserve the rights to modify, add, and/ or delete and / or change either whole or part of the ICAR Empanelment Rule without any notice and the same shall be binding on the contractors enlisted with revenue.
