Different quotations should be submitted for HQ as well as respective regional Centres.

The contour intervals should be @ 1.0 m or less.  The reporting of building details has to be given as per <b>Annexure-II</b> .  3 sets of Topographical Maps (hard copy) alongwith softcopy of the same compatible with latest AutoCAD/GIS software has to be submitted after conducting the survey.	Per Hactre (Ha)	(in figures as well as in words)  Rate should include all kind of taxes, transportation, lodging etc.
