OPEN TENDER

Sealed bids are invited for procurement of **Milking Machine for Dairy Unit** from the reputed registered firms/ manufacturers/ authorized dealers by ICAR Research Complex for N.E.H. Region, Umroi Road, Umiam, Meghalaya. The detailed specifications of the items (Annexure – I), terms & conditions, etc are given below:-

1. Every **tenderers** shall have to deposit consolidate cost of Tender paper **Rs.500.00** (Rupees five hundred) only, (**Non- refundable**) to be deposited in favour of the Director, ICAR Research Complex for NEH Region, Umiam, by means of Demand Draft payable at SBI, ICAR Complex Branch, Umiam. Non – submission of the cost of the Tender paper shall lead to non – consideration of the Tender.
2. **The tenderers** [except those who are registered with the Central Purchase Organization & National Small Industries Corporation (valid proof should be mandatory enclosed)] **shall have to mandatory deposit consolidate Earnest Money Deposit for Rs.2,500/- (Rupees two thousand five hundred) only in the form of Demand Draft valid for 6 (Six) months, drawn in favour of the Director, ICAR Research Complex for NEH Region, Umiam, Meghalaya, payable at SBI, ICAR Complex Branch, Umiam, along with the quotation. Non compliance to this shall lead to non consideration of the tender. The cost of tender paper as well as the Earnest money deposit should mandatory be kept in the Technical Bid (Bid 'I') only.**
3. The Tender should consist of two Bids- The Technical bid (**Bid 'I'**) and the Financial bid (**Bid 'II'**). Both must be submitted in two separate envelopes to be sealed and put in a single main cover. The outer main cover should be super scribed **"TENDER No.RC/AP/Store/Accessories/2016 dt.15.09.2016 for procurement of Milking Machine for Dairy Unit, Division of Livestock Production, ICAR (RC) for NEH Region, Umiam,** and addressed to **"THE DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION UMIAM, MEGHALAYA-793103"**. You should give the complete address on the bottom left corner of the Main Cover. Tenders may be sent by Registered Post or may be hand delivered in the Tender box, kept in the Office Chamber of the CAO's/AAO(S) ICAR Research Complex for NEH Region, Umiam, Meghalaya-793103 not later than **12:30 P.M. on the 6th October, 2016.** Tenders received after the due date and time shall not be considered under any circumstances.
4. **Furnishing of related documents like detailed specifications, technical literature, brand name, model and make, catalogue, authorization letter, Dealership Certificate, Manufacturing company registration certificate, product certification, price list (if any) etc. is mandatory. Dealership certificate/Agency Certificate for the manufacturer/ manufacturing firm should be enclosed if the rates are quoted by the Dealers/Agents. Sales tax certificate, tax clearance (up – to date), valid CST/VAT registration certificate, last 3-5 years financial standing etc. along with all the commercial terms and conditions. Failing which the quotation shall not be considered.** Financial bids of the technical acceptable offers would only be considered for further evaluation and analysis. Non-compliance of this shall lead to non-consideration of the Bid.
5. **The financial bid should consist of the rates only.** Price quoted for each particular item should be enclosed separately and must be given per unit and must be all inclusive, including packing, forwarding, delivery, taxes, VAT etc., as may be applicable. The amount of discount, etc. offered by the bidder should be specifically shown as admissible. **The rates quoted should be upto ICAR Research Complex for NEH Region, Umiam,** for the mentioned items. The rates must be valid for at least for 01 (one) year from the date of quotation.
6. The Buyer shall not be responsible for payment of transit insurance charges.
7. Payment shall be made only on actual delivery in good condition and successful installation and demonstration (which should be free of cost and must be completed before payment).
8. **ICAR Research Complex for NEH Region, Umiam, Meghalaya, being a Scientific and Research Organization, is exempted from payment of Excise Duty (Certificate to this effect will be provided).**

9. The scope of supply shall include all equipment, tools, tackles, accessories, auxiliaries and mountings including all electrical works required for the satisfactory operation of the equipment described hereunder.
10. Minor electrical works like fixing of the equipment/instrument, extension of the control/power cables etc. shall be carried out by the contractor/tenderer.
11. Any material and equipment not specifically stated in this specification but which are necessary for satisfactory operation and commissioning of the equipment/instrument shall deem to be included in the scope of supply.
 - a) In case of delay in supply, **penalty will be imposed @2% per week**, subject to a maximum of 10% of the FOB value.
 - b) Indian Agents quoting on behalf of their principal must be registered firms with DGS&D .They are also requested to provide necessary authorization letter from their principal along with the quotation.
12. Performance Bank Guarantee is required for all indigenous items also. For items less than Rs.50,000/- the amount should be 5% of the actual cost of the equipment and for items more than 50,000.00 the amount should be 10% of the actual cost of the equipment. The bank guarantee should cover the entire guarantee/ warranty period which should be of at least one year duration.
13. The selected bidders must complete the supply/ repairing/installation/ demonstration within the stipulated time limit mentioned in the supply order. In case, the firm fails to execute the supply within the time limit, the bid security would stand forfeited and supply order shall be cancelled.
14. The guarantee/ warrantee should be from the date of installation. All guarantee/ warranty services should be attended within a maximum limit of 15 days, failing which, proportionate deductions from the security deposit may be made at the discretion of the Institute.
15. **The Director, ICAR Research Complex reserves the right to reject any tender in part or full, without assigning any reason thereof.**
16. Legal jurisdiction for all disputes shall be within the purview of the Shillong Court.
17. **The Firm/ Agency run by the Non-Tribal should produce Trading License issued by the KHADC & also produce Municipal Trade License as applicable state to state & Tribals should provide Schedule Tribe Certificate, failing which the tender are liable to be rejected. Non submission of Trading License, tender rates shall be rejected / not to be considered.** ~~The participants the tender from State other than Meghalaya have to obtain (KAD) Certificate from the Government of India.~~
18. **You should mandatory sign on every page of the Tender Document, which would show their unconditional acceptance of all the terms and conditions of the Tender Document.** You shall give an undertaking that they fully and unconditionally agree to abide by all the terms and conditions which, if needed, may be modified at the discretion of the Competent Authority, in supply order, for which confirmation from the supplier shall be taken.
19. You should mandatory give your current, PAN Card No., TDS& other Bank A/C details to enable the office for releasing the dues via e- payment basis.
20. *In case of further enquiry may please contact the HOD, Livestock Production Division, ICAR (RC), Umiam.*
21. The Techno-Commercial Bids shall be opened on **6th October, 2016 at 02:30p.m.** in the Committee Room, Administrative Block, ICAR Research Complex for NEH Region, Umiam, Meghalaya. Interested bidders may attend the opening.
22. If the above mentioned closing /opening day of the tender happened to be non - working date due to Bandh/Strike as any other reasons, the tender will be received & opened on the following working day at the same time except on the 2nd (second) Saturday.
23. Other terms & conditions, as may be decided by the Competent Authority from time to time, depending upon the condition & requirement of the supply. The intimation in this regard, shall be provided well in advance & the bidder/ supplier shall be bound by the said terms & conditions.
