#### **Open Tender Notice**

ICAR Research Complex for NEH Region, Umiam is organizing Exhibition cum Workshop on Traditional indigenous farming of food and food products of the Northeast to be held on 15<sup>th</sup> – 17<sup>th</sup> February, 2017 at ICAR Research Complex for NEH Region, Umiam under TSP Project.

In pursuance of the above proposal, invites tender for Event Management and supply of Materials Infrastructure Facilities and Services.

Sealed bids are invited for **Event Management and supply of Materials Infrastructure Facilities and Services towards Exhibition cum Workshop on Traditional indigenous farming of food and food products of the Northeast to be held on 15<sup>th</sup> – 17<sup>th</sup> February, 2017 at ICAR Research Complex for NEH Region, Umiam under TSP Project from the Party/Decorator/Caterer/Publicity/Individual/Contractor/Firm etc. on behalf of The Director, ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya – 793103. The detail specifications of the item (Appendix -I) and terms & conditions etc. are as given below:-**

## **Terms & Conditions of the Tender**

- 1. The consolidate cost of Tender document Rs.500/- (Rupees five hundred) only (Non Refundable) to be deposited in favour of the Director, ICAR Research Complex for NEH Region, Umiam by means of Demand Draft payable at State Bank of India, ICAR Complex Branch, Umiam(12464), Meghalaya. Non submission of the cost of Tender document shall lead to non consideration of the Tender.
- 2. Each quotation should consist of two Bids, namely "Bid I Techno commercial bid" and Bid II Financial bid". Both must be submitted in two separate envelopes to be sealed, superscribed as 'Bid I or Bid II' and must be put in a single outer main cover. The single outer main cover should be superscript as "Tender No.SS/Exhibition/Tender dtd.25.01.2017 for Event Management and supply of Materials Infrastructure Facilities and Services towards Exhibition cum Workshop on Traditional indigenous farming of food and food products of the Northeast to be held on 15<sup>th</sup> 17<sup>th</sup> February, 2017 at ICAR Research Complex for NEH Region, Umiam under TSP Project" and addressed to "THE DIRECTOR, ICAR RESEARCH COMPLEX FOR NEH REGION, UMIAM, MEGHALAYA 793103 (INDIA)". The bidding firm should mention their complete address at the bottom left corner of the main cover. The cover letter, cost of the Tender and Earnest money for Rs.10,000/- (Rupees ten thousand) only alongwith all other Technical details should be mandatorily kept in Techno commercial Bid (Bid I). The Financial Bid (Bid II) should consist of the Rates, their detail break up etc as mentioned at Appendix I. Non-compliance of these shall lead to non-consideration of the Bid. Financial bids of technically acceptable firms shall only be considered for further evaluation.
- 3. All Tender should be sent through Registered Post. Tenders to be hand delivered should be put in the Tender Box, kept in the office of the Director, ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya 793103. Bid document sent through Email shall not be considered. The tender should reach to the office on or before 8<sup>th</sup> February, 2017 up to 11:30 AM. Tenders received after due date and time shall not be considered under any circumstance.
- 4. All interested parties such as Temporary construction of Pandals, Erection of Dias, Stalls, Registration counter, Toilets for Ladies and Gents, Food Pandals, and Pandal for accommodation of 500 (five hundred) Farmers should complete in all respect before 13<sup>th</sup> February, 2017 positively.
- 5. Sales tax certificate, tax clearance (up to date), valid CST/VAT registration certificate etc. should be enclosed.

#### 6. KHADC license.

I. The Firm/Agency run by the Non-tribal contractor's /firms/companies/ suppliers/ stockiest/ banded warehouse/Private carriage contractors/Co-operative Societies etc. should produce Trading License issued by the KHADC (Govt. of Meghalaya) and may be kept in the Technical Bid (Bid – I).

II. Submission of tender paper does not fall under trade as per the above said act. However, if a Non-tribal becomes a successful bidder he has to furnish License issued by the KHADC (Govt. of Meghalaya) before any work involving trade is issued to him.

Further those firm/agency opting for clause II above are requested to submit an undertaking mandatorily to this effect along with the technical bids as a certification about their capability of submission of the trade license when ask for, failing which the tender are liable to be rejected/not to be considered at any circumstances. (If not applicable submit the relevant document).

- 7. The rates quoted should be up to F.O.R. ICAR RC, Umiam (Door delivery) and the establishing, temporary construction and installation/labour charge/supply of temporary materials like tarpaulin, bamboo, water, generator, cloth sealing, flowers, carpet, electrification works, necessary furniture, chair, display cards, extra tables, tables cloth VIP chairs, fire extinguisher portable, sofa, LED lights, First Aid box etc. should be done at ICAR RC Umiam. The quoted rate should be in Indian Rupees. The rates must be valid for a minimum period of one year from the date of quotation.
- 8. Price quoted (in INR) must be given per unit including all packing, forwarding, delivery charges, temporary construction of Pandals and installation charges, permissible taxes, duties, VAT etc. as may be applicable. The ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya 793103, shall not be responsible for payment of transit insurance charges.
- 9. All bidders should mandatorily give their valid PAN Card No. (Photocopy of the PAN card to be enclosed), TAN (if any) and Bank A/C details (Name, Account No., Bank, Branch, IFSC Code and MICR Code etc.) along with the bid to enable the office for releasing the dues via e payment.
- 10. The Party/Firms etc. shall have to deposit an earnest money of **Rs.10,000/-** (Rupees ten thousand only) in the form of Demand Draft drawn in favour of the Director, ICAR Research Complex for NEH Region, Umiam payable at State Bank of India, ICAR Complex branch, Umiam (12464) as bid security along with the quotation. The cost of tender as well as the earnest money along with all other Technical Details should be mandatorily kept in the Techno commercial Bid only. Non submission of the earnest money with bid document shall make the quotation liable to be rejected. The earnest money of non successful bidder will be refunded after bids are finalized.
- 11. The establishing, temporary construction and installation should be completed in time and with F.O.R. destinations/door delivery. The selected bidder must complete the temporary construction/supply/installation/demonstration within 13<sup>th</sup> February, 2017 positively and handover to the concerned officers of the office.
- 12. Supplier/Caterer/Publicity/Party etc. should complete the work on or before 13<sup>th</sup> February, 2017 positively failing in which their EMD money deposited shall be forfeited by the office for which an undertaking is required to be submitted alongwith the quotation.
- 13. Precautionary measured like fire safety etc. should also be taken care.
- 14. No advance payment/ part payment shall be made against the order. No additional charges above the quoted price shall be entertained. Payment shall be made on successful completion of work in toto.
- 15. All bidders shall give an undertaking on their official letter head duly signed along with official seal that they fully and unconditionally agree to abide by all the terms & conditions which, if needed, may be modified at the discretion of the Competent Authority in supply order, for which confirmation from the supplier shall be taken. Non submission of the undertaking may lead to rejection/non consideration of the tender.
- 16. The bidders should mandatorily sign on every page of the Tender Document, which would show their unconditional acceptance of all the terms and conditions of the Tender Document.
- 17. The Institute does not pledge itself to accept the lowest or any other tenders. The institute is also not bound to accept the tender in whole and Institute has right to accept the tender in parts. The tenderers are however, at liberty to tender for the whole or any portion of it or to state in the tenders that the rates quoted shall apply only if the tenders are considered fully. Other conditional tenders will not be accepted.

- 18. The Director, ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya 793103 reserves the right to reject any tender in part or full without assigning any reason thereof. The decision in this regard shall be final for any aspect of the contract and binding on all parties.
- 19. Disputes arising, if any will be settled by mutual consultation and in case of failure of settlement dispute shall be referred to the sole arbitrator to be appointed by the Director, ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya 793103. The decision of the sole arbitrator so appointed shall be final and binding on both the parties. Otherwise, all dispute arising related to this contract will be settled in the Court of Law at Shillong, Meghalaya and verdict of the Court of Law shall be binding to both the parties.
- 20. Tender shall be opened on 8<sup>th</sup> February, 2017 at 11:30 AM in the office of the Director, ICAR Research Complex for NEH Region, Umroi Road, Umiam, Meghalaya 793103. Interested bidders or their authorized representative(s) may attend the opening. No enquiry or unlawful pursuance about the quotations will be entertained.
- 21. If the above mentioned closing and opening day of the tender happens to be non-working day, the tender will be received and opened on the following working day at the same time.
- 22. Other terms and conditions, as may be decided by the Competent Authority will be intimated from time to time, depending upon the conditions and requirement of the supply. The intimation in this regard shall be provided well in advance and the bidder/suppliers shall be bound by the said terms & conditions.
